TERMS AND CONDITIONS

I hereby certify that I am nineteen years of age or older and I agree to abide by the guidelines, policies, procedures, and by-laws of the Okanagan Club for Skiing, Sports and Socials, hereinafter referred to as "the Club".

In consideration of the club accepting my application for membership and permitting my attendance at the Club events and activities, I hereby agree as follows:

1. TO WAIVE ANY AND ALL CLAIMS that I have or may have in the future against the Club, and its directors, employees, agents, and representatives, all of whom are collectively referred to as "the Releasees" and the release the Releasees from any and all liability from loss, damage, injury or expense that I may incur, or that my next of kin may suffer as a result of my attendance at any Club event or activity due to any cause whatsoever, including negligence, breach of contract, or breach of any statutory or other duty of care, including any duty of care owed under the OCCUPIERS LIABILITY ACT R.S.B.C 1979, C.303, on the part of the Releasees.
2. TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any damage to property of, or personal injury to, any third party, resulting from my attendance at the Club events and activities.
3. This Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, assigns, and representatives, in the event of my death or incapacity.
4. This Agreement shall be governed by and interpreted in accordance with the laws of the Province of British Columbia; and,
5. Any litigation involving the parties to this agreement shall be brought within the Province of British Columbia. In entering into this Agreement I am not relying upon any oral or written representations or statements made by the Releasees other than what is set forth in this Agreement.

MEMBERSHIP POLICY

Members must be nineteen (19) years of age or older and agree to abide by the by-laws and rules of the Constitution derived by the Club as defined under the Societies Act of British Columbia.

Members understand and agree to abide by a code of conduct at all club events. Any illegal or abusive behavior will not be tolerated and is just cause for immediate loss of membership, without refund of any fees paid.

Any disputes with the club's policies or procedures must be submitted in writing to the Executive.

There will be no refunds on membership dues once payment has been made to the Club.

Members must be in good standing to be entitled to the benefits and privileges of the Club.

Memberships are not transferable.

Memberships and renewals are subject to acceptance by the Executive of the Club.
